"Make education fit around the child, not the child fit around the education, including if they're more advanced with their learning." The point this parent was making referred to the idea of having a more tailored approach to learning levels for children, according to their ability rather than their age/stage.

"Too much focus on academic, more practical routes are needed. For example in Germany there are three different types of school depending on the type of education."

"We need an education system that focuses on teaching children to think for themselves, to be critical thinkers and know how to debate and take on other people's views without conflict. There are too many tick boxes around reading and writing."

"Take a person centred approach to learning."

"Better interpersonal and dynamic interaction with teachers, not just a transactional relationship."

"A flexible approach to timing, allow repeat years more easily, move the system according to capacity not age."

"Help neurotypical children learn how to make friends with nerodiverse children."

The point this parent was making was that the emphasis should be on making neourodiverse children feel included, rather than trying to get them to fit into a mould.

"Don't just teach by repeating knowledge."

The group struggled to come up with anything they thought needed to stay. This was a group of parents of children with additional support needs (most of their children were neurodiverse). Instead of focussing on what needed to stay, parents suggested getting rid of GIRFEC and in reference to Curriculum for Excellence, they said more doing and less talking was required. One parents did comment on how useful they had found it to have one named person as a key point of contact for their child and how great it was they could easily communicate with them by various methods, especially as the person was trained and knowledgable in supporting children with ASN. The other parents commented they didn't have a similar specific contact. This fed into a previous discussion we'd had about the fact there was a huge amount of inconsistency with the delivery of additional support for learning across schools.

This point was echoed by other parents with a general feeling of being completely cut out and ignored. "staff need to recognise that a diagnosis isnt needed to be able to appropriately support a child with ASN." "Improving the diagnostic process and system." Another parent argued that earlier diagnosis is needed and waiting times need to be reduced. "more effective use of digital technology for learning and assessments," One parent commented that her child had been prevented from answering questions in an exam using a digital method despite them having significant issues with writing by hand." "more flexibility is needed in placements and approaches - there is no one way to work with autistic children." "support children who are intelligent and articulate but who struggle massively with exams to be able to achieve their qualifications." more joined up thinking and better understanding of what disability is and how it affects people differently." "more standards and consistency needed across Scotland in support for learning." "Schools need to do more rather than inauthentic ways of showing support." This point was being made in reference to 'virtue signalling' events a school might have on raising money or awareness for a specific cause while not addressing fundamental issues and needs of children with asn. "teachers need to be open to learning on how to support an individual." "better more targeted specific training is required." This was thought to be harmful for children's wellbeing and a waste of resources "more focus on wellbeing rather than on academic acheivements is needed at certain times, e.g during covid." "more use of lunch time and break time clubs." "recognise digital learning isnt right for all with the push for digital learning." "make sure children and young people feel safe enough to tell you they're no OK." "ensure there is space for everything that is needed, example a 'nurture room." One parent gave an example of how a teacher made the decision to cut their office in half so the space could be used for a nurture room after a new school building hadn't made space for one in new plans.

"dont highlight attendance stats if young person wants to learn and achieve their best but can't always give full attendance due to asn."

"allow children to join class digitally if it gets too much to be there in person."

"its vital the school show they care about wellbeing, ask how kids are, be person centred."

"too much focus on uniform instead of on social and emotional needs."

"understand the challenges for children's asn around constraints of wearing a tie or uniform in general,"

"recognise the strength of online friendships and their importance to wellbeing." This parent was making the point kids are not always just mindlessly looking at social media apps, they make genuine friendships online and find them safer."
